**HOLD HARMLESS/RELEASE FROM LIABILITY**

The undersigned acknowledges that they are riding and handling horses on the property and business location of Mission Equine, Inc./Faith Equestrian/Mission Farrier School (MEqI/FEq/MFS), with the permission of said Stable. However in giving permission, it is understood and agreed by the undersigned that MEqI/FEq/MFS assumes no responsibility for any injury or damage incurred by the riding and handling of horses by the undersigned.

The undersigned does hereby release Mission Equine, Inc./Faith Equestrian/Mission Farrier School from any and all liability incident to the riding and handling and the presence of the horses owned or leased by the undersigned, at this facility. The undersigned does fully assume all the inherent risks in the riding and handling of horses on our about said premises. Such riding and/or handling of horses without the expressed written permission of Mission Equine, Inc./Faith Equestrian/MFS, shall be deemed a violation of the general rules and regulations.

1. Parties: This agreement is entered into for the benefit of Mission Equine, Inc. and/or Faith Equestrian and/or Mission Farrier School, it's employees, owners, officers, shareholders, and agents, and with the undersigned attendee/releasor ("Releasor") as defined below.

2. License: By signing this document, the Releasor accepts the grant to attend a clinic, show, exhibition, seminar, event, or board, in the buildings and on the grounds of Mission Equine, Inc./Faith Equestrian/Mission Farrier School, which Releasor has inspected and accepts as suitable for Releasor's participation or attendance.

3. Release, Hold Harmless, Waiver, Pledge: The undersigned releases and agrees to indemnify and hold harmless Mission Equine, Inc., and/or Faith Equestrian and/or Mission Farrier School, and, on behalf of Releasor's wards, charges, children, family, visitors, agents, individually and as guardian or personal representative, covenants not to sue for special and general damages, by whomever sustained, resulting from property damage, injury, or loss of life (Claim) caused by the conditions on the said property of MEqI/FEq/MFS, and stable owners, the activities of the Stable, its employees, guests, clients, and boarders and their family or guests, and the Releasor's horse, and further agrees to hold harmless and indemnify Mission Equine, Inc./Faith Equestrian/MFS against any such Claim whether presented by another, individually, or in a representative capacity, and further waives and releases subrogation claims of all medical, disability, property and liability insurers, including, but not limited to, damage resulting from medical and convalescent care, cost of support; and, as security for this hold harmless and indemnity, Releasor grants and pledges a security interest in all money and proceeds arising from any such Claim including insurance proceeds, trust and guardianship remainders and proceeds from testate or intestate succession, which Releasor agrees not to relinquish or disclaim.

Furthermore, the Stable owner and/or management and/or employees shall not, be held responsible for any accident, illness, injury, death, fire or theft. I understand and accept the responsibility and risks inherent & associated with stabling, boarding, owning, riding, handling, conditioning, training, breeding & transporting horses, and I acknowledge that Mortality, Medical/Major Medical, Loss of Use, and any other insurance is solely my responsibility. I acknowledge that the stable carries Care, Custody & Control at a maximum coverage of \$10,000 per horse, & \$100,000 per loss aggregate, AND, **I Agree to that amount.** If I cannot agree with that amount, I will not stable my horse at this facility.

4. Hard-Hat/Helmet: I, the undersigned, recognize the dangers inherent with horseback riding. I am assuming the risks of this hazard upon myself since I wish to handle and ride horses. I realize I am subject to injury from this activity and no form of preplanning can remove all danger to which I am exposing myself. The use of a hard-hat could prevent permanent brain damage in the case of an accident, and I understand that this facility strongly recommends that I use one. I assume all risks involved in handling and riding horses without a hard-hat/helmet.

5. Effective Period: The agreement granted herein and the release, hold harmless, indemnity, waiver, and pledge, shall remain in effect and in force until terminated by either party in writing, and so applicable at subsequent Events.
